## EAPP EXPERT MEETING

"CHALLENGING YOUTH—PERSONALITY DEVELOPMENT IN ADOLESCENCE"

#### ORGANIZER

#### ABSTRACT

Adolescence, as important phase in the development of who we want to be, is still under-researched with respect to personality trends and processes. While research demonstrated the existence of the well-established adult personality structure in adolescence, developmental trends are not that well understood (Soto & Tackett, 2015). For example, the continuity principle might apply already for adolescent personality, mean level trends, as described in the maturity principle, could not be supported. In contrary, longitudinal findings illustrated nonlinear trends suggesting a disruptive hypothesis around early to middle adolescence with social desirable traits rather decreasing (van den Akker et al., 2014). Yet existing theoretical notions are unable to explain such trends. To arrive at an integrative framework, we need to integrate the diverse topics of research contributing to personality development in adolescence (e.g., education (Spengler et al., 2013), social relationships (Wagner et al., 2018), identity (Klimstra & Denissen, 2017)).

We propose to gather expertise across seven areas of adolescent personality research to be able to form an integrated view on developmental trends and processes. To do so, we want to bring together a group of experts with distinct knowledge on adolescent developmental processes, influencing factors, and its assessment.

Accordingly, the purpose of the meeting will be twofold:

 We want to advance a theoretical integration on personality development in adolescence that is informed by different perspectives. We aim at writing an interdisciplinary review paper to disseminate the results of this expert meeting, possibly as a target article at EJP to invite the field to critically reflect on our work.
We want to facilitate collaborative research projects and set the floor for planning interdisciplinary and multicentric studies to test our theoretical framework of personality development in adolescence. The expert meeting will also be one first initiative to identify possible further funding opportunities.

### LIST OF PARTICIPANTS

This is not the final list of participants; rather we would like to gather a final group of up to 15 experts that are situated at seven key topics of research on personality in adolescence. The seven areas of expertise are listed below. In addition to content related selections, our participants are chosen for three further reasons: First, to adequately represent the dynamics in this research area, we aim to bring together experts that are promising younger researchers as well as more established senior researchers. Second, we seek for an equal distribution of female and male experts. Furthermore, we aim to take advantage of expert-meetings of the last years and seek to integrate members of two relevant former expert meetings on "Modern approaches to the conceptualization and assessment of personality traits" and on "Integrating personality structure and processes".
